# **BRADFORD COUNTY 4-H EXHIBIT ROOM** @ the Bradford County Agricultural Fair



Registration Deadline: Friday, February 21, 2025 by 4:00 PM Item Check-In: Wednesday, February 26, 2025 8:00 AM - 4:00 PM at the Bradford Extension Office

- 1. All entries and exhibits must be appropriate and acceptable per the Bradford County Extension Staff and Fair Association.
- 2. Exhibitors must be enrolled in Bradford or Union County 4-H or FFA for 2024-2025 program year.
- 3. Entries must be the work of the individual and completed within the last twelve (12) months.
- 4. Entries should be the result of 4-H/FFA project work. School projects, essays, posters, and science projects are not acceptable unless they are directly related to a 4-H/FFA project that the member is enrolled in.
- 5. All entries must remain displayed until Saturday March 8, 2025 at 8:00 PM. Premium and ribbons will be forfeited if exhibits are removed before that time. There will be no Sunday pickups. Entries that are not picked up Saturday evening must be picked up from the Bradford Extension Office during business hours between Monday, March 10 and Friday, March 14. Unclaimed entries will be disposed of.
- 6. Ribbons and premiums will be awarded based on judging criteria. Judge's decisions are final.
- 7. The Fair Association, management, or 4-H staff will not be responsible in case of damage or loss of exhibit.
- 8. Cloverbuds (4-H members ages 5-7) will not be judged in competition, therefore will be awarded participation ribbons and premium monies.
- 9. A maximum of three (3) entries will be allowed in each exhibit area per member.

# **4-H EXHIBIT AREAS**

Up to three (3) items per exhibit area may be entered.

## Area 1 – Photography

Must be an 8x10" in size and must be framed in a plain black, brown, or white frame. Photos will not be judged based on the frame – framing is for preserving the photo from damage.

## Area 2 – Educational Materials (posters, infographics, pamphlets)

Must have an educational objective directly relating to a 4-H project and should include the 4-H clover.

#### Area 3 – Woodworking

Any item carved or created from wood.

#### Area 4 – Clothing & Textiles

Any clothing that was made (sewn, knitted, etc.) by member and can be worn.

#### Area 5 – Fiber Arts

Any non-clothing item knitted, crocheted, cross-stitched, or sewn by member.

#### Area 6 – Scrapbooking

Complete themed scrapbook or collage (single page)

#### Area 7 – Jewelry

Any item created with wire, leather, string or beads that can be worn.

#### Area 8 – Creative Arts

Any item created from scratch by member from materials including but not limited to; clay, wax, popsicle sticks, paper mâché, glass, leather, etc.

#### Area 9 – Decorated Items

Any pre-purchased item decorated by member.

#### Area 10 – Paintings & Drawings

Any painting or drawing created by member. Paintings or drawings must be framed or matted to a hard surface for easy display.

#### Area 11 – Poetry and Stories

Must be framed or in a binder.

# Area 12 – Canned Goods

Must be made placed in standard canning jars with rust free lids/rings.

# Area 13 – Edible Plants\*

Any plant that is classified for human consumption, including fruits trees, nut trees, vegetables, or other edible plants.

# Area 14 – Ornamental Plants (Non-Flowering)\*

Any plant used for ornamental or visual uses, including indoor plants, cacti, and succulents, grasses, foliage plants and ferns, or shrubs and woody ornamental plants.

# Area 15 – Ornamental Plants (Flowering)\*

Any plant that is flowering and used for ornamental or visual uses, including indoor plants, cacti, and succulents, grasses, foliage plants and ferns, or shrubs and woody ornamental plants.

# \*Plant Division Regulations:

- No plant will be accepted that is listed on the State of Florida Conservation list as rare or endangered, or if it is listed as an invasive species by state and federal standards.

- All plants must be clean, groomed, and in an appropriate pot/container.
- Any plant with pests or diseases will be disqualified
- Entries will be judged on category criteria and container selection and condition.
